#### BOARDING CONTRACT

- Owner understands all board must be paid monthly and in advance. Board is due on the first (1st) of each month, timely payments are strictly enforced. A late fee of \$15.00 will be charged on payments received after the fifth (5th) of the month. Should owner fall two months or more behind in board, management will have right to sell owner's horse to recover lost board and professional fees if any. Any excess over monies owed will be refunded to owner. No refunds will be made on board already paid and all outstanding bills due management must be settled before removing horse.
- This horse, to the best of my knowledge, has not been exposed to any contagious or infectious disease for two weeks prior to boarding.
- Every precaution is taken to protect the horse from illness, accident, fire and theft. The stable owner and/or stable management shall not, while exercising reasonable care, be held responsible for accident, illness, fire or theft. Veterinarian services, vanning and any miscellaneous expenses are additional costs and be billed accordingly. Management reserves the right to notify the Owner at any time if horse, in the Manager's opinion, is deemed dangerous, sick or undesirable for a boarding stable. In such case, Owner is responsible for removing horse within seven (7) days and for all fees incurred during horse's stay.
- Management strongly recommends that Owner carry liability insurance for any injury caused by his/her horse, if so covered then a certificate of liability insurance with the stable named as additional insured would be required by the stable management for each horse. Additionally it is the Owner's responsibility to carry full insurance including coverage on his horse and all personal property if desired.
- All boarders are required to follow management's scheduled worming and inoculation program.
- Owner understands training, lessons, shoeing, veterinarian and other professional are the owner's responsibility.

This agreement can be cancelled by either party upon 15 days written notice.
